Income

- Pay As You Go (PAYG) summaries.

- Lump sum payments.
- ☑ Social security, pensions, and allowance statements.
- ☑ Trust distribution statements.
- ☑ Tax statements from fund managers.
- ☑ Bank statements showing interest and fees.
- ☑ Dividend statements.
- Contract notes for any buy or sell transactions.
- ☑ Tax statements from stockbrokers.
- ✓ Income stream statements.
- Statement for income received from life insurance payments.

Deductions

- ☑ Receipts or evidence of work-related deductions (e.g. home office, travel, tools,
- ☑ Receipts or evidence of self-education expenses (e.g. fees, books, computer costs).
- ☑ Union fees.
- Statements for car finance lease.

Offsets

- ☑ Private health insurance statement.
- ☑ Details of dependants (include name, D.O.B. and legal responsibilities).
- ☑ Spouse details (income, D.O.B.).
- ☑ Zone details (if you live in a remote area, you may be eligible for an offset).
- parent/spouse/housekeeper/low income household.
- ☑ Superannuation pension rebates.
- ☑ Medical receipts.
- ☑ Imputation credit information from dividend statements.
